This warranty refers to the cost of product parts whose coverage is provided by Atom Seating® in the event of a claim. Costs for the warranty are mentioned in the below section - "Parts Warranty – Coverage and Limitations".

Limitations

- All warranties are applicable to the original purchaser from parts purchased from Atom Seating® authorized dealers only. Atom Seating® Warranties are not transferable.
- All warranties are limited only to manufacturing and material defects that appear under normal, indoor use. Additional limitations described herein apply.
- Warranties are applicable for replacements of parts or repair in Atom Seating®'s sole discretion. REFUNDS ARE NOT APPLICABLE.
- During the Limited Warranty Atom Seating® will not be responsible for any initial or subsequent inspection fees or any transportation costs related to this Limited Warranty. As these are not considered a covered expense.
- This warranty does not cover any damages due to improper use, excessive soiling, improper or unapproved cleaning methods, chemical treatments, exposure to direct sunlight or colour fading. These instances will void the warranty.
- Warranties do not apply to purchases of floor samples or "AS IS" products except as required by law.
- Except as set forth in this warranty and to the extent provided by law, in no event will Atom Seating® be liable for incidental or consequential damages, even if it had reason to know in advance that such damages were possible.
- If within the warranty period, identical materials are unavailable at the time of repair or replacement, Atom Seating® reserves the right to substitute materials, of equal or better quality. Replacement leathers or fabrics may vary in colour or texture from the original due to the inherent nature of leather and dye lot differences.

Making A Claim

Parts Warranty - Coverage And Limitations For Recliners

Atom Seating® provides a comprehensive five (5) year warranty on all Recliner parts including Motor, Mechanism, and Frame. For this five (5) year warranty, Atom Seating® will cover 100% of the cost of parts excluding the freight. Freight will be covered by the client for all five (5) years.

ELECTRICAL COMPONENTS AND UPHOLSTERY - One (1) Year for accessories as well as upholstery (Leather coverage does not include natural markings, shrinkage, stretching, or variations in grain or colour, which occur naturally and prove the authenticity of the leather. Fabric fading, pilling, shrinkage, stretching, wearing quality and colour fastness are not covered by this warranty).

For this One (1) year warranty, Atom Seating® will cover 100% of the cost of parts excluding freight. Freight will be covered by the client for all one (1) year.



Parts Warranty - Coverage And Limitations For Rockers

Atom Seating® provides a comprehensive (3) year warranty and (8) year quality warranty on all Rockers parts except of any accessories and upholstery. . For this three (3) year warranty, Atom Seating® will cover 100% of the cost of parts for (3) years excluding freight. Freight will be covered by the client for all three (3) years.
